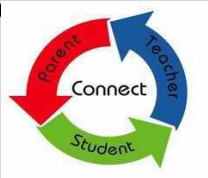

### What is Title

I?



In support of strengthening student academic achievement, Scintilla Charter Academy (SCA) has developed this parent and family engagement policy that establishes the school's expectations and objectives for meaningful family engagement and guides the strategies and resources that strengthen school and parent partnerships at SCA, a Title I school. This plan will describe SCA's commitment to engage families in the education of their children and to build the capacity to implement family engagement strategies and activities designed to achieve the student academic achievement goals.

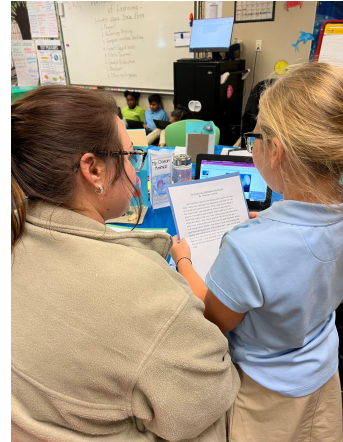
When schools, families, and communities work together to support learning, children tend to do better in school, stay in school longer and enjoy school more. Title I, Part A provides for substantive family engagement at every level of the program, such as in the development and implementation of the school plan, and in carrying out the school improvement provisions. Section 1116 of the Every Student Succeeds Act (ESSA) contains the primary Title I, Part A requirements for schools and school systems to involve parents and family members in their children's education. Consistent with Section 1116, SCA will work with its Title I schools to ensure that the required school-level parent and family engagement policies meet the requirements of Section 1116(b) and each include, as a component, a school-parent compact consistent with Section 1116(d) of the ESSA.

## PARENT AND FAMILY ENGAGEMENT POLICY

### What is Parent and Family Engagement?

Parent and Family Engagement means the participation of parents and family members in regular, two-way, and meaningful communication involving student academic learning and other school activities, including ensuring:

- (A) That parents play an integral role in assisting their child's learning.
- (B) That parents are encouraged to be actively involved in their child's education.
- (C) That parents are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child.
- (D) The carrying out of other activities, such as those described in Section 1116 of the ESSA.

### School-Parent Compacts

The school-parent compact is an agreement developed jointly by the school, parents and scholars. The compact explains what the teachers and parents agree to do that will help our students reach high academic standards. The compact will be reviewed and revised annually based on feedback from parents, scholars, and teachers.

### Parent and Family Engagement Evaluation

Each year, SCA will conduct an evaluation of the content and effectiveness of this parent and family engagement policy and the family engagement activities to improve the academic quality of the Title I schools through an annual parent survey and stakeholder meetings.

Throughout the year, copies of the Parent and Family Engagement Policy are available for review in the front lobby along with stakeholder input forms. In the spring, SCA will send home a survey and email a link to the survey for parents to provide valuable feedback regarding the parent and family engagement activities and programs. These surveys will also be posted on SCA's website for parents to complete. Paper copies are available by request. In addition to the annual survey, SCA will also use stakeholder meetings to facilitate group discussions to discuss the needs parents of children eligible to receive Title I services to design strategies for more effective family engagement.

SCA will use the findings from the survey results and stakeholder meetings to design strategies to improve effective family engagement, to remove possible barriers to parent participation, and to revise its parent and family engagement policies and school improvement plan.

### Accessibility

In carrying out the parent and family engagement requirements established by Section 1116 of the ESSA, SCA's Director of Engagements will ensure full opportunities for participation of parents with limited English proficiency, parents with disabilities, and parents of migratory children including providing information and school reports in a language parents can understand.

This schoolwide parent and family engagement policy has been developed jointly and agreed upon with parents and family members of children participating in Title I, Part A programs as evidenced by the collaboration and opportunities for input of families and school personnel.
